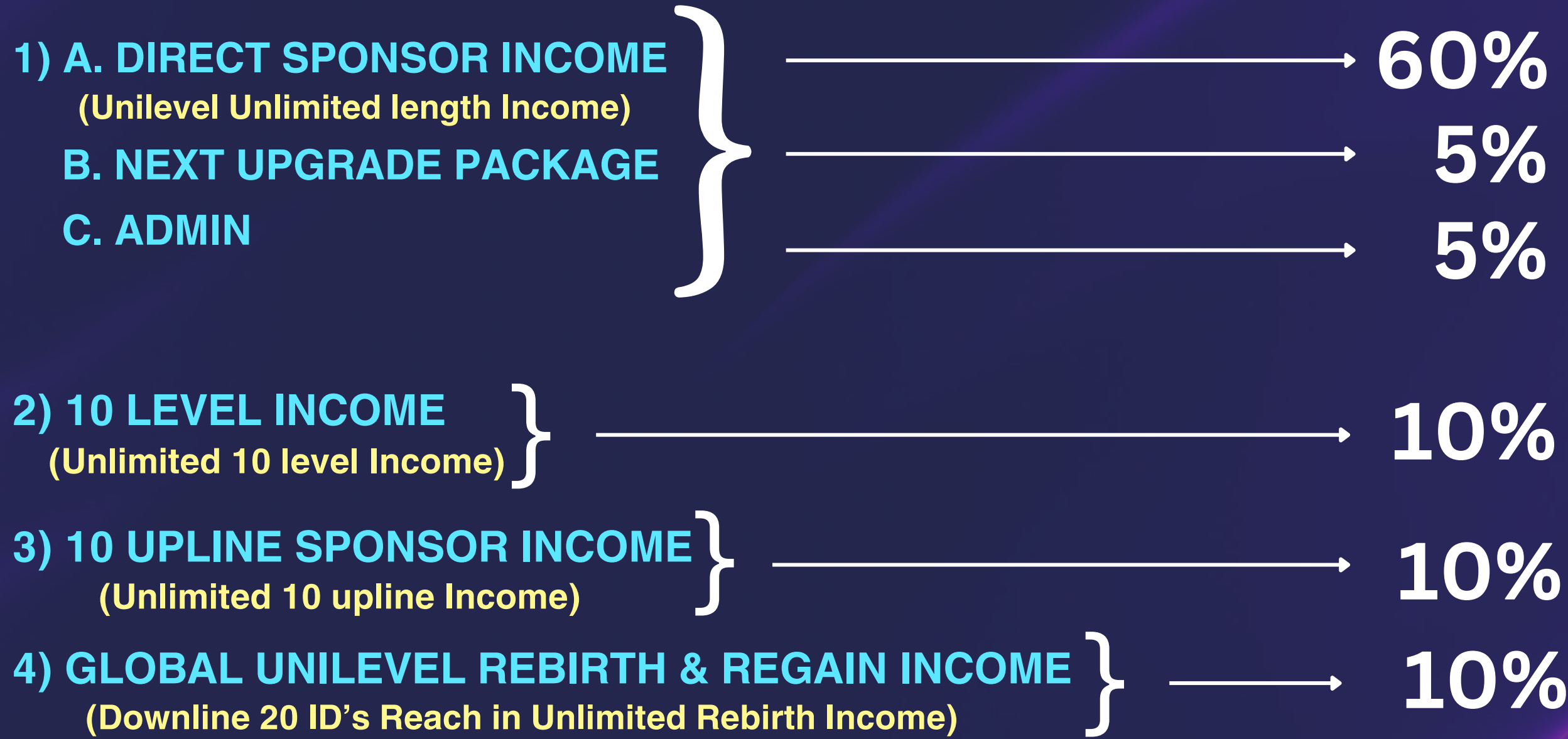

TYPES OF INCOMES

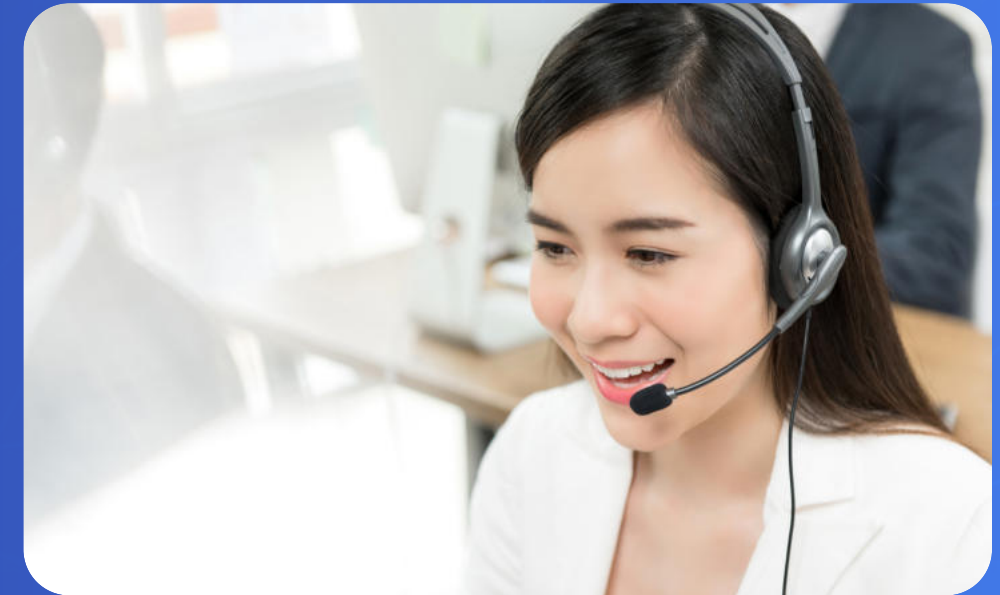

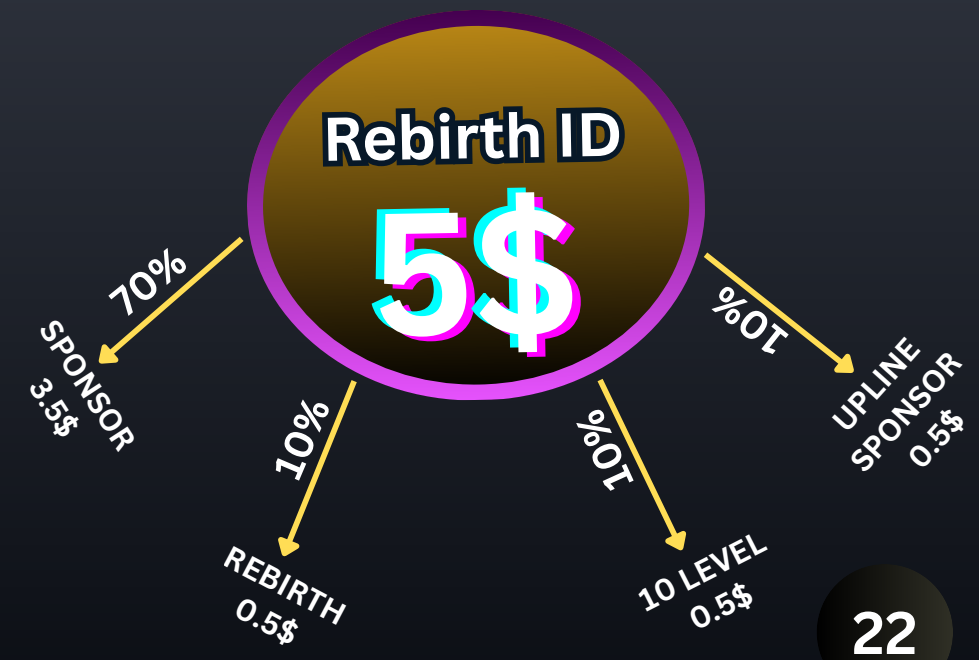

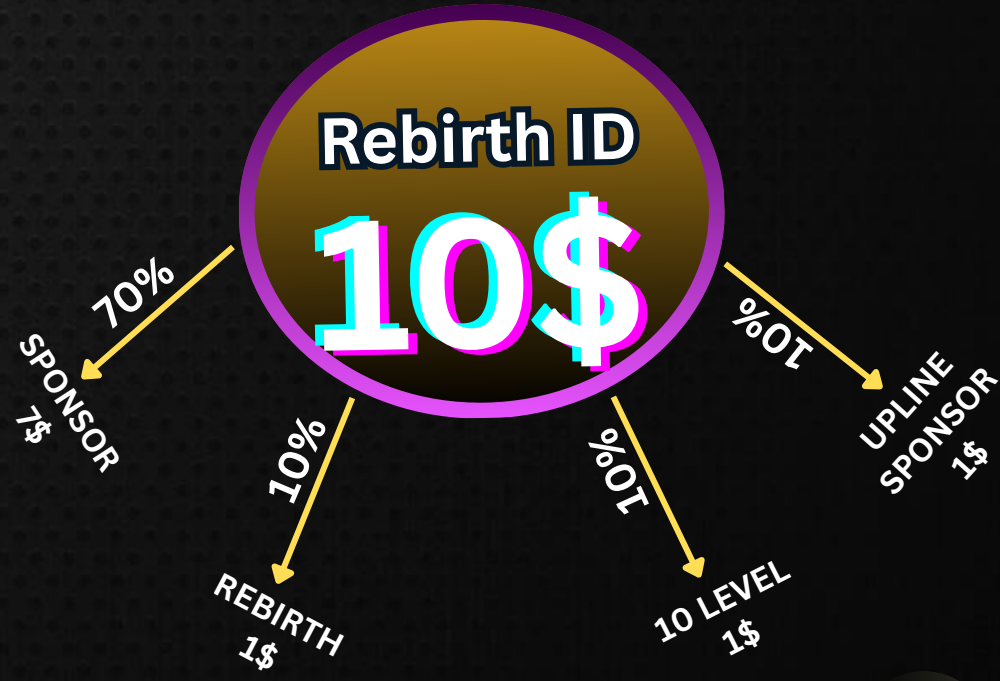


Global 10\$ GOLD Unilevel Rebirth & Regain Income 10%
